ABOUT RESULTS

Charity can move millions, but advocacy can move billions.

Results International (Australia) - Results - is a non-partisan international aid and development organisation. We advocate to Australian parliamentarians with the aim of leveraging millions of dollars in government funding for the world's poorest communities in the Asia Pacific region.

For 35 years we have recruited, trained and empowered everyday Australians through our grassroots advocacy program. We enable our advocates to use their voice to ensure Australia is a good international citizen and directs its overseas aid budget to some of the best anti-poverty initiatives in the world.

Our model of grassroots, policy and parliamentary advocacy enables us to create

transformational change for some of the world's poorest communities. Throughout our history, we have generated significant government investment in priority areas including global health, education, nutrition, and women and girls.

Results is one of only two development agencies in Australia dedicated to advocating for global health equity. We believe that, no matter where people are born, everyone should have equal opportunities to fulfil their potential in life.

With head, hands and heart, Results has contributed to some of the biggest wins in the fight to end global poverty. From mobilising millions of dollars to alleviate diseases of poverty such as tuberculosis and polio, to ensuring millions more children have access to basic education.

CHAIR'S REPORT

CEO'S REPORT

As I reflect on Results' activities and achievements over the last year I am deeply inspired by our staff and advocates, and their dedicated work for a fairer and more prosperous world. At a time of aid volatility, the growing impacts of the climate crisis and humanitarian crises gripping large parts of the globe, the role of citizen advocates could not be more important.

In 2024, Results continued to focus on the issues that have long been at the heart of our work: health equity, education, nutrition, and women and girls. We also expanded our focus to include the health effects of climate change. We saw some encouraging 'wins' for global health from the Australian government, with new investments in TB treatments (\$17 million) and regional health systems (\$45.5 million). We also launched our #351 for the Global Fund, and Voices for Vaccines campaigns, calling on the Australian Government to invest its fair share in the Global Fund to Fight AIDS, TB and Malaria and Gavi, the Global Vaccine Alliance.

At the same time Results' Advocates created public awareness for TB, with twenty two buildings and monuments across the country lit up in red for World TB Day on 24 March. Across an eight-month period, our third intake of Global Health Fellows developed their skills, deepened their learning and supported our calls for the rights of all people, everywhere, to access healthcare.




At Results' annual Leadership Awards we celebrated our political, media and advocate champions in the fight to end global poverty. TUBERCULOSIS ADVOCACY

In March 2024, Results convened a **high-level parliamentary breakfast** focused on Tuberculosis (TB) innovations and treatment access. This highly successful event featured:

- The Hon Pat Conroy, Minister for International Development and the Pacific, who announced Australia's A\$17 million commitment to the TB Alliance to support new treatments for TB.
- Shadow Minister for Foreign Affairs the Hon Simon Birmingham, who reinforced bipartisan support for the fight to end TB.
- A panel discussion, facilitated by Australia's Ambassador for Global Health, Lucas de Toca, featuring experts Simone Barry (South Australia Health), Khai Li Huang (Burnet Institute), and Jamie Triccas (University of Sydney).





In November 2024, Results also contributed to the **Asia Pacific TB Forum**, which marked the 10-year anniversary of the TB Caucus. CEO Negaya Chorley presented on Australia's progress towards TB targets, strengthening connections with key partners in TB advocacy.



TUBERCULOSIS ADVOCACY, CONT.

In November 2024, Results contributed to the **Union Conference** with a session titled *The Power of Advocacy in Global Health*. Led by our CEO and Global Health Manager, alongside partners from Results Canada and GFAN, the three-hour session covered the role of advocacy in global health, strategy development, communication, and the 20-year history of Global Fund advocacy. The session highlighted how advocacy plays a key role in fighting tuberculosis, in addition to other infectious diseases like malaria and HIV.





GLOBAL HEALTH FELLOWSHIP

In 2024, Results' Global Health Fellowship equipped nine emerging leaders with the skills to influence global health policy. Over six months, fellows participated in expert-led sessions on policy, advocacy, media engagement, and research, while gaining practical experience engaging with MPs, policymakers, and global health leaders.

Fellows attended key national and international conferences, including the World Health Summit Regional Meeting and the Global Health Security Conference, where they connected with experts and deepened their understanding of global health challenges. An in-person retreat in Melbourne provided further opportunities for collaboration and leadership development.

The Fellows produced two research papers, *Innovations in Global Health* and *Partnering for Women's and Children's Health*, showcasing their ability to conduct impactful, evidence-based advocacy. These reports were sent to over 100 MPs highlighting the need for increased ODA, particularly in the Indo-Pacific region.

Through this program, Results continues to cultivate the next generation of global health leaders, ensuring stronger advocacy for health equity in the Indo-Pacific and beyond.

GRASSROOTS ADVOCATES

Results' volunteer advocates use their voice to influence the Australian Government decision-makers to improve policies, renew commitments and increase financial resources for a more equitable world.

Throughout 2024, our network of over 100 advocates participated in a range of learning sessions to deepen their understanding of global health issues and strengthen their advocacy skills, to confidently call on the Australian Government for greater action to end poverty. Through these learning sessions, our advocates wrote letters and met with their local MPs to build awareness of the importance of increasing ODA and investing in global health initiatives such as Gavi, the Vaccine Alliance and the Global Fund to Fight AIDS, Tuberculosis and Malaria. Our advocates engaged with members of parliament from all sides of politics.

ADVOCATE TRAINING: BUILDING COMMUNITY KNOWLEDGE

Results' busy advocate program included seven webinars and online training sessions for our advocates across a range of topics. The diverse range of expert speakers shared their knowledge, with special thanks to Chelsea Beech (Beech Agency), Hunter Lee & Athalia Foo (Today), Richard Di Natale (Former Leader of the Australian Greens), Results Staff and Silver Scribes.

SAFER WORLD FOR ALL CAMPAIGN

The Safer World for All campaign is a national initiative urging Australian leaders to take action to address global challenges and build a more equitable and secure world for all.

In 2024, Results joined forces with the Safer World for All (SWFA) campaign to advocate for an increase in Australia's Official Development Assistance (ODA) to 1% of the federal budget. Australia is one of the safest, healthiest, and most generous countries in the world. Yet, our aid contribution is only 0.68% of the FY2024-25 Federal Budget. SWFA is advocating for a moderate increase that would make a world of difference.

Australia can show its commitment to being a good international citizen, strengthen regional stability, unlock economic opportunities and put the world back on the path to progress, peace and prosperity.

We are proud to work with key partners including Micah, Australian Council for International Development, Caritas Australia, Action Aid and Save the Children.

As part of this broader effort calling for a step up in ODA, we wrote to over 107 MPs, urging them to support the Global Fund and Gavi replenishments.

This advocacy was a crucial step in ensuring Australia plays a stronger role in global health and poverty reduction, reinforcing the need for sustainable, long-term funding for vaccines, and testing and treatment for HIV, TB and malaria in the Indo-Pacific region. Through direct parliamentary engagement and collaboration with civil society and policy leaders, Results continues to push for greater Australian leadership in global health financing.



351 FOR THE GLOBAL FUND CAMPAIGN

The Global Fund invests billions of dollars every year to defeat HIV, TB and malaria and ensure a healthier, safer, more equitable future for all.

In December 2024, Results launched its Global Fund 8th Replenishment campaign, **351 for the Global Fund**, calling on the Australian Government to pledge A\$351 million for the 2026-2028 funding cycle. This represented a 32% increase from Australia's previous commitment and aimed to ensure continued support for lifesaving treatments for HIV, TB, and malaria, particularly in the Indo-Pacific region.

To reinforce this ask, Results coordinated a closed letter to Foreign Minister Penny Wong, with support from civil society and research organisations, advocating for increased Overseas Development Assistance and a stronger Global Fund contribution.

In parallel, Results partnered with the Asia Pacific TB Caucus, engaging Members of Parliament to write to the Australian consulate. As a result, Indonesia, South Korea, India and Papua New Guinea sent formal letters highlighting the critical role of Global Fund investments in the region.



VOICES FOR VACCINESCAMPAIGN

Gavi, The Vaccine Alliance, is a public-private partnership that helps vaccinate more than half the world's children against some of the world's deadliest diseases.

In 2024, Results led a Gavi campaign, Voices for Vaccines, focusing on recruiting and empowering campaigners to advocate for a strong Gavi replenishment in 2025. The campaign included training sessions designed to equip Results' advocates with essential advocacy skills to effectively engage with policymakers and the public.

The campaign's training program featured a variety of expert-led sessions, including:

- Introduction to Gavi, which provided an overview of Gavi's critical role in vaccinating children in low-income countries.
- Amplifying your message on social media, led by Beech Advocacy, teaching participants how to engage online audiences and promote the cause effectively.
- Writing for Advocacy with Today, focusing on crafting persuasive messages for policy change.
- MP engagement, facilitated by Richard Di Natale, former Senator of Australia, which offered valuable insights into how to effectively engage parliamentarians and advocate for increased funding for global health initiatives.

Following these sessions, advocates were encouraged to write to their MPs, with many securing meetings with their local parliamentarians to press for a strong Gavi replenishment in 2025. This campaign not only mobilised a passionate group of advocates but also reinforced the importance of collaborative, grassroots advocacy in achieving tangible progress on global health issues.





LEADERSHIP AWARDS

In May 2024, members of the Results' community from across Australia and around the world gathered in person and online to take part in our annual Leadership Awards Event. The theme "Democracy on the edge: the fight for human rights and a prosperous world" highlighted the role of citizen-led movements in safeguarding our democracies. Results brought together Sam Daley-Harris (founder of the Results movement in the USA) and Caitlin Figueiredo (2024 ACT Young Australian of the Year), with the wonderful emcee Briony Benjamin (story teller and changemaker).

The Leadership Awards celebrated the amazing work of our volunteers, journalists and parliamentarians who have shown outstanding leadership in the fight against global poverty: Rahab Mwaniki (outstanding contribution to advocacy), Alex Norden (outstanding contribution to Grassroots Fellowship Program), Stephen Dziedzic of the ABC (media leadership award) and Kate Thwaites MP (political leadership award).

OUR MEDIA IMPACT


Results' advocacy throughout the year gained significant media attention, helping to amplify key messages and mobilise public and political support.

For World TB day alone we achieved:

- 115 media mentions of CEO Negaya Chorley and Results across online and print, up from 80 in the previous year.
- Coverage in major outlets, including The Sunday Telegraph (op-ed), The Canberra Times, News Corp, and ABC regional.
- Audience reach of 5.52 million, up from approximately 3 million the previous year.
- Additional radio coverage on ABC Far North Breakfast, ABC North and West, and Eyre Peninsula.

Through targeted advocacy, parliamentary engagement, and media outreach, Results continues to strengthen Australia's leadership in global health. By advocating for increased investment in HIV, TB, malaria, and vaccine equity, we are working towards a future where more people have access to the healthcare they need.

Boughly every 20 seconds, someone dies from taherculosis, making it one of the deadliest diseases in the world.

Though Australia's rates of tubercrites is an extremely low, most of its global burden is home by close neighbours.

It has reached crisis levels for many countries in Asia and the Pacific and remains a threat in Americana, especially after disruptions consed by the COVID-19 pandomic led niberculosis deaths to sise for the first time in more than a docade.



Penny Wong announces \$17m funding injection to treat TB scourge in the Asia-Pacific

Results CEO Negaya Chorley drives the call for greater investments in TB in our region in this piece published in news.com.au on 25 March.

Foreign Minister Penny Wong will direct \$17m to fight the tuberculosis scourge that continues to cripple Southeast Asia and The Pacific, though one international aid agency says the money won't be enough to wipe out the curable illness.

Ms Wong announced the commitment on Sunday ahead of World Tuberculosis Day, with the funds set to support the Global Alliance for Tuberculosis to develop and trial a new generation of "drug-resistant" tuberculosis treatments, including for children.



This Impact Report represents the achievements and financial report of Results International (Australia) Inc for the year ended 31 December 2024. Results is a not for profit organisation incorporated as an Association in New South Wales.

Results is a secular, independent and non-profit organisation. While we, our volunteers and our partners advocate to educate and inform parliamentarians and government, this is carried out in a non-partisan way to all members of the government, opposition and minor parties and their advisors in accordance with the Results Non-Development Policy.

As a registered charity with Deductible Gift Recipient (DGR) status, donations of \$2 or more to Results are tax deductible in Australia.

Results is an Affiliate Member of the Australian Council for International Development (ACFID).

We share ACFID's vision of a world where all people are free from extreme poverty, injustice and inequality, and where the earth's finite resources are managed sustainably.

FINANCIAL SUMMARY

How we raise our funds

Results receives the majority of its funding from RESULTS Educational Fund (US) through the ACTION partnership, which is funded by major US philanthropists. In 2024, we received A\$733,184 from ACTION. With additional income from our other major donors, including QIAGEN and SILA, as well as monetary and in-kind donations, local fundraising and other activities, Results' total income came to A\$896,319. The CEO, staff and Board continue to work hard to create new funding opportunities to increase and diversify our income from a range of other supporters and donors, ensuring Results has a strong and sustainable income stream.

How we spend our funds

62% of our funds were spent on community education to guide and invest in skills development to amplify the voices of our volunteers. It enabled Results to run a successful Grassroots Fellowship Program, allowed volunteers to attend training, workshops, advocates to visit MPs and Senators in Canberra, write effective letters and undertake other activities described in this report. Our fundraising expenditure continues to be minimal, while 29% was spent on essential administration and accountability expenses including auditing, IT, travel, personnel and operational costs, supporting our core campaigning.

Our current financial position

Careful management of expenditure enabled a surplus of A\$6,467 as at 31 December 2024. Retained earnings are important to ensure we are in a position to continue to achieve impact in the years ahead. This boosted retained earnings to A\$455,762 at year end which, coupled with a renewed four year grant from RESULTS Educational Fund (US), provides confidence to pursue planned activities for 2025 and beyond.
